

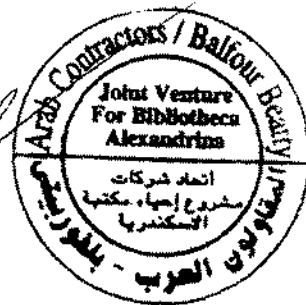

- Assisting quantity survey department preparing the take off of formwork and concrete and rebar.


Performing his job activities, Eng. Mohamed Shafeik was found to be more than satisfactory and his discretion is absolute.

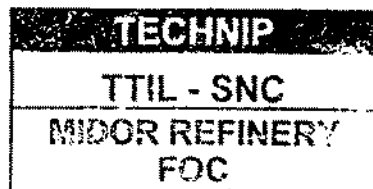
